Date of declaration of merit list	04 September 2018
Date of seat allotment and admission in B.D.S seats of Dental Colleges	5 <sup>th</sup> & 6 <sup>th</sup> September 2018 (From 10:00 AM)
<b>On Spot admission will have to be completed on the same date after allotment of seat from 2<sup>nd</sup> MOP UP Round.</b>	

- 1- The 2<sup>nd</sup> MOP UP Round will be held at Kalam Centre, KGMU Lucknow.
- 2- All the eligible candidate of NEET UG 2018 will have to deposit Rs. 1000.00 as registration fees Online and will have to register again on the website of <https://upneet.gov.in> NIC, to attend 2<sup>nd</sup> Mop-up round.
- 3- Candidates already admitted through all India quotas and the candidate of first or second counseling of state (Alloted/admitted/resigned) are not eligible for 2<sup>nd</sup> MOP UP Round.
- 4- The Candidates will have to deposit their educational, caste certificate and other documents in original at the time of 2<sup>nd</sup> MOP UP Round, other wise there candidature will not be considered.
- 5- Demand draft of Rs. 2,00,000/- for Private Dental seats payable at Lucknow in favour of "Director General Medical Education & Training, U.P.", will have compulsory deposited as security. Security money will not be accepted in cash at any cost.
- 6- The Candidates who have been allotted the BDS seats in private dental colleges and who have deposited the Rs. 2,00,000/- Lac as security money, that will be deducted from their tuition fee and the rest amount will be deposited to the concern dental college's as tuition fee at the same time.
